South Bay served by our Santa Clara and San Jose Medical Centers. We invite you to apply for grant funding as part of our effort to address this area's priority health needs. We provide funding and resources to support programs, community partners, organizations, and agencies in the cities of Santa Clara County.

Health Care Access & Delivery

Grant range: \$10,000-\$50,000

Healthy Eating, Active Living

Grant range: \$10,000-\$50,000

Strategies

- Support healthy food incentive programs for CalFresh participants
- Support medically tailored meal programs for low-income individuals
- Support organizations that make healthy food available to low-income, minority families
- Support farmers markets on college campuses for low-income young adults and other community members
- Support for school-based healthy meals and health & wellness policies
- Support fitness programs for older adults at public community centers
- Support after-school fitness programs at schools
- Support outreach and enrollment campaigns to increase CalFresh enrollment for eligible community members

Expected Outcomes

Increased opportunities for physical activity for youth and older adults. Increased food available to low-income, minority families.

Housing and Homelessness

Grant range: \$10,000-\$50,000

Strategies

- Support programs that help low-income homeowners stay in their homes
- Support supportive services for individuals experiencing homelessness
- Support for transitional housing, which includes case management, job & housing search assistance, financial literacy, and life skills education
- Support long-term housing and support services for domestic violence victims and their children who are homeless or at risk of homelessness
- Support efforts to house transitional-aged former foster youth
- Support medical social work through backpack medicine, mobile clinics, medical respite, and/or volunteerism at local clinics
- Support mobile hygiene outreach programs offered in combination with supportive services
- Support employment opportunities for individuals experiencing homelessness
- Implement health care workforce pipeline programs to introduce diverse, underrepresented school age youth and college students to health careers

Outcomes

Individuals and families receive the supports necessary to prevent homelessness.

ELIGIBILITY GUIDELINES

Only nonprofit 501(c)(3) tax-exempt organizations, educational, and governmental entities are eligible to receive Kaiser Permanente Community Health grants. Unincorporated groups or programs may utilize an eligible nonprofit agency as their fiscal agent. Current and past grantees are also eligible to apply.

Kaiser Permanente will not consider funding requests from the following types of organizations or for the following activities/purposes: partisan political, fraternal, athletic, international, for-profit or social organizations; endowments; memorials; individuals; field trips; or tours.

Kaiser Permanente has an unwavering commitment to equal access and opportunity for all persons. Organizations receiving funding must provide attestation that they do not discriminate based on race, color, religious creed, national origin, age, sex, marital status, sexual orientation, gender identity, disability, medical condition, or veteran status in their programs, services, policies, hiring practices, and administration.

SELECTION CRITERIA

Kaiser Permanente receives many requests for support from nonprofit and government agencies doing important work in the community. Ideally, the identified strategies align with what the applicant organization is already doing, and measurement of the expected outcome is already in place or relatively easy to implement. Our funding, then, would support an ongoing effort with a defined cohort of persons receiving services over a 12-month period. Since these are modest one-year grants, we don't expect applicants to propose a whole new program or hire new staff, and grantees must have a plan to sustain these efforts through fundraising and/or service contracts.

GRANT REVIEW PROCESS

- Full online proposals are reviewed and approved by the KP-South Bay Community Health Investment Committee using the criteria above. The Committee recommends grant awards for funding.
- The Community Health Investment Committee composed of hospital leaders reviews and approves the grants recommendations and the area's Senior Vice President authorizes funding.
